Subject: Media Release (December)

December 31, 2016

On December 3, 2016, Police issued a town ordinance violation warning to a Piermont resident for being parked and facing traffic on the wrong side of the road on Route 25, in Piermont.

During the month of December, the Piermont Police Department also took 39 administrative phone calls, 3 walk-in assists or complaints, conducted follow up investigations, responded to building alarms, medical calls and issued 27 motor vehicle warnings for a variety of violations.
