Subject: Media Release (June)

June 30, 2017

On June 9, 2017, Police issued a citation to a Mountain View, CA, resident for excessive speed on River Road, in Piermont.

On June 9, 2017, Police issued a citation to a North Haverhill, NH, resident for excessive speed on Route 10, in Piermont.

On June 12, 2017, Police issued a citation to a Woodsville, NH, resident for operating an unregistered motor vehicle on Route 25C, in Piermont.

On June 14, 2017, Police issued a citation to an East Corinth, VT, resident for operating and unregistered motor vehicle on Route 10, in Piermont.

On June 14, 2017, Piermont Police Chief, Gary Hebert, was on patrol on River Road when he captured a motor vehicle on his radar unit traveling 89 mph in a 35 mph zone. After a pursuit from Piermont and into the Haverhill NH jurisdiction, the vehicle was stopped by NH State Police. The driver, Jonathan Jacob, 36, of Woodsville, NH was arrested and charged with class A Misdemeanor, Disobeying an Officer and Driving after Suspension-subsequent offense. He was also charged with a motor vehicle violation of Reckless Operation. Mr. Jacob refused the services of a bail commissioner and agreed to appear before a Judge within 24 hours. Mr. Jacob was retained at the Grafton County House of Corrections and is due to appear in the Haverhill District Court on June 15, 2017. Mr. Jacob's Probation Officer was contacted regarding this incident and arrest.

On June 15, 2017, Police responded to a residence on Aaron Rd., in Piermont, for a reported domestic disturbance. Further investigation revealed no crime was committed. The male party involved removed himself from the situation and peace was restored.

July 31, 2017

On July, 28, 2017, Police issued a citation to a Lebanon, NH, resident for driving after revocation/suspension on Route 25, in Piermont.

On July 29, 2017, Police, Fire and EMS responded to a single motor vehicle accident on Route 25, in Piermont. Minor injuries were reported, but the driver refused transport to the hospital. It was determined that the operator, Christopher Rodimon, 35, of Piermont, NH, was under suspension during the period of suspension for a DWI. Mr. Rodimon was arrested for Op. after Suspension and later released on \$1,000 Personal Recognizance bail with a court date of September 18, 2017, at 8:00 am, at the Haverhill District Court. He was also issued a citation for Displaying a False Inspection Sticker.

During the month of June and July, the Piermont Police Department took 120 administrative calls, 1 walk-in assist or complaint, conducted follow up investigations, responded to building alarms, numerous VIN checks, medical calls and issued 36 motor vehicle warnings for a variety of violations.
