Subject: Media Release (October)

October 31, 2017

On October 2, 2017, Police issued a motor vehicle citation to a Whitefield, NH, resident for excessive speed in a school zone on Route 10, in Piermont.

On October 13, 2017, Police issued a motor vehicle citation to a White River Jct., VT, resident for excessive speed on River Road, in Piermont.

On October 13, 2017, Piermont Police attempted to stop a motor vehicle for speeding on Route 25, in Piermont. The operator of the vehicle sped away and a pursuit ensued. The pursuit continued into Bradford, VT, where Vermont State Police (VSP) became involved. A short time later, with the assistance of some citizens, the vehicle was located and the operator arrested by VSP for violations that occurred in their jurisdiction. An arrest warrant was requested by Piermont PD and granted on the operator for a number of charges.

On October 16, 2017, The Piermont Animal Control Officer issued a canine control citation to a Piermont, NH, resident, for failing to abate their barking dogs.

On October 18, 2017, Police issued a motor vehicle citation to a Canaan, NH, resident for operating without a valid license (expired), on Route 10, in Piermont.

On October 20, 2017, Police issued a motor vehicle citation to a Piermont, NH, resident for operating an unregistered vehicle on Route 25C, in Piermont.

On October 23, 2017, The Piermont Animal Control Officer issued a canine control citation to a Piermont, NH, resident, for failing to abate their barking dogs. The citation was the third offense within a 12 month period. The resident was summons to appear on December 11, 2017, at 8:00 am, at the Haverhill District Court.

On October 23, 2017, Police issued a motor vehicle citation to a Cornwall, VT, resident for excessive speed in a school zone on Route 10, in Piermont.

On October 23, 2017, Police issued a motor vehicle citation to a Bradford, VT, resident for excessive speed on River Road, in Piermont.

During the month of October, the Piermont Police Department also took 48 administrative calls, 4 walk-in assists or complaints, conducted follow up investigations, responded to building alarms, medical calls and issued 42 motor vehicle warnings for a variety of violations.
