The meeting was called to order by Chairman Stubbings at 7:10pm. He stated that meetings are no longer being recorded, however others in the room may be recording but have not declared the fact.

Avitar Revaluation/Update Agreement; Avitar Associates sent in the updated contract for the 2021 revaluation. Total cost will be \$30,720 (to be billed in monthly installments). Selectman Subject made a motion to approve agreement. 2nd by Selectman Godfrey. All in favor. 3-0. Motion passed.

Part Time Police Pay Rate; Selectboard discussed a rate of \$35.00 per hour for Gary Hebert on a part time basis. Selectman Subject made a motion to accept rate. 2nd by Selectman Godfrey. All in favor. 3-0. Motion passed.

Selectboard Meeting Schedule (October); Dates have been set for October for Selectboard meetings and work sessions. Selectboard will meet October 13th and October 27th. Selectboard will hold work sessions on October 8th and 22nd.
