

BOARD OF SELECTMAN – WORK SESSION

OLD CHURCH BUILDING

THURSDAY OCTOBER 8, 2020

Board members in attendance: Chairman Colin Stubbings, Selectmen Randy Subject and Wayne Godfrey.

Members of the Public also in attendance: Sandi Pierce (Admin Asst), Brandon Alling

The meeting was called to order by Chairman Stubbings at 7:01 pm. He stated that meetings are no longer being recorded, however others in the room may be recording but have not declared the fact.

No public input will be allowed during work sessions unless majority voted by Selectboard.

Randy Subject led the Pledge of Allegiance.

Presidential Election Warrant; Chairman Stubbings read the warrant. Selectman Subject made a motion to accept. 2nd by Selectman Godfrey. All in favor. 3-0. Motion passed.

Herbicide; John Metcalf advised the Selectboard he will be spraying herbicides according to the policy on October 12th and 13th at the Landfill.

Correspondence; Ammonoosic Community Health Services sent in an appropriations request for 2021 in the amount of \$335.00. Upper Valley Lake Sunapee Regional Planning Commission sent in for budget purposes membership dues in 2021 in the amount of \$1,106.79. Public Health Council of the Upper Valley sent in an appropriation request for 2021 in the amount of \$588.00. Selectman Subject made a motion to accept all. 2nd by Selectman Godfrey. All in favor. 3-0. Motion passed.

Any Other Business; Chamber of Commerce has reached out to speak to local business owners in Town. Selectman Godfrey to follow up with Chamber of Commerce to get scheduled. Conservation Commission land lease was not signed by Lisa Knapton as she is still under contract with the State of New Hampshire to plant rye. She will sign the lease when it expires in 2021. Town received a municipal aid payment in the amount of \$7330.68. We budgeted for these funds therefore no need to accept. Chairman Stubbings made mention of the MS434 and MS535 needing to be completed to get the tax rate set.

Non-Public Session was entered at 7:20 pm citing RSA 91-A:3, II (b) after a motion by Selectman Subject to enter, 2nd by Selectman Godfrey, vote to enter 3-0 in favor.

Exited Non Public at 7:58 pm.

Chairman Stubbings announced Brandon Alling has accepted the position of Police Chief for Piermont. Selectman Subject made a motion to accept the rate of pay sheet for Brandon Alling. 2nd by Selectman Godfrey. All in favor. 3-0. Motion passed.


